WHAT IS CONNORCAN/CONNOR'S KLOSET?

Connor was a beautiful young man that learned how to ride at the age of 2 and had everything going for him. When he was 19 years old he would take a machine out to run everyday after work. In July 2019 he took his quad out without putting on his helmet , he did a wheelie and something went terrible wrong as he landed straight back only injuring his head. Connor suffered a severe brain injury and battled and won many things from the injury for about 13 months. During that time his friends and family had nothing but hope and used ConnorCan as his word of encouragement. November 29, 2020 he could no longer fight the fight and passed away. During this time his mom Christine sought out help and found The Social Brain which is located in Suffolk County and has become the Nassau County branch to the medical needs closet. Her dream is to open Connor's Kloset and do more for the medical closet needs.

Safety procedures being put into place for this event as of time of permit, plan will follow current CDC Guidelines at time of the event.

-no one will be allowed in without a mask, we will provide a mask to those in need

- -we will have one way in and one way out
- -all hands will be sanitized when entering and leaving
- -wipes and sanitizer will be very visible throughout the event

-each motorcycle will be 6ft apart and owners will alternate sitting in front of or behind their bike to maintain a safe distance

- -staff members will remind all attending to maintain 6ft distance
- -6ft markers will be placed on the ground to guide guests
- -food items will only be allowed to be eaten in separate areas from the majority of people
- -we will have professional grade spray bottle sanitizer and paper towels for anything needed
- -garbage pails will be centrally located and changed out frequently
- -all food servers will wear masks and gloves
- -anyone working with cash or credit cards will wear gloves and not touch anything else
- -mini golf pencils will be provided so everyone has their own
- -the property will be cleaned and left better than we found it


